



Dominion Road – Spend and Score on Dominion Road Terms and Conditions:

1. By participating in this Competition, you confirm that you accept and agree to these Terms & Conditions.
2. The Promoter is the Dominion Rd Business Association Incorporated (hereafter 'DRBA').
3. The Sponsors are Dominion Road Business Association and Eden Park.
4. The Competition is called "Spend and score on Dominion Road "
5. **The Promotional Period is 12:01am Saturday 6th July 2024 to 11:59pm Sunday 11th August 2024.**
6. There will be one draw. Winners will be notified by telephone and/or by email. If the winner(s) cannot be reached by email or telephone within three working days, the Promoter may redraw a new prize winner without liability to any person.
